

Applying for Post-Completion Optional Practical Training (OPT)

Eligibility:	
	You must currently be on Post-Completion OPT
	You must have received your diploma before you apply for STEM OPT.
	You must have an E-verify employer to apply for STEM Extension

Frequently asked questions:

Do I need a job offer to apply for STEM OPT? Yes, you need a job where you have a direct supervisor and your employer is E-verified.

Which majors are eligible for STEM OPT? Currently, all Graduate courses offered at HU are STEM OPT eligible.

How long is OPT? STEM OPT Extension authorization is for 2 years (24 months).,

When should I apply for OPT? You can apply up to 90 days before your OPT end date. USCIS must receive your documents before your OPT end date or you will be denied.

What is my program completion date? Your program completion date is the last day of the semester in which you complete degree requirements, not your graduation or degree awarded date.

When can I start working? As long as you file your STEM OPT extension application on time, if your OPT period expires while your extension application is pending, USCIS will automatically extend your employment authorization for 180 days. This automatic 180-day extension ceases once USCIS adjudicates your STEM OPT extension application.

Can I be unemployed while on OPT? Yes, DHS allows STEM OPT students an additional 60 days of unemployment during the 24-month STEM OPT extension period (on top of the initial 90 days allowed on Post-Completion OPT).

Can I travel while on STEM OPT? Yes. However, it is not recommended to travel outside of the U.S. if you have not found a job or are unemployed.

What are the additional requirements for STEM OPT? You must submit an I-983 form to a DSO before applying for STEM OPT AND anytime you change an employer. You will also be required to submit 6-month STEM validation reports. A DSO will send you a reminder of when these are due.

Form I-765 questions:

- **5. Address:** This is the place where USCIS will send your EAD card. Write in the address where you will receive mail in 3 months. USPS cannot forward this letter.
- **8. What is my alien registration number?** Your alien registration number is listed on your EAD card (9 digits)
- **27.** What is my eligibility category? 24-month STEM Extension OPT is (c) (3) (C). Please be sure to also answer all of Question #28

Requirements:

- ☐ Your employment while on STEM OPT must relate to your major or program of study.
- ☐ You may change jobs, but must remain employed. In order to change jobs, you MUST inform a DSO. You will need to submit your last date of employment, final self-evaluation on page 5 of your I-983 form, and your new I-983 form for your new employer.
- 1. Notify the International Student Office that you are applying for STEM OPT and inform a DSO if you will be changing employers. We will issue a new I- 20 recommending you for STEM OPT.
- Within 60 days of the International Student Office issuing you an I-20 for STEM OPT and before your OPT expires, you must submit your application for OPT to the United States Citizenship & Immigration Service (USCIS). All OPT applications are approved by USCIS and the International Student Office has no ability to influence the process.

	Gently write your name and I-94 number on the back of both photos.						
	An OPT I-20 from university recommending STEM OPT. Previous I-20s are not needed.						

3.	Once yo	Photocopy or scan your I-765 form (recommended). Send your application within 60 days of your STEM OPT I-20 issuance date to the United States Citizenship and Immigration Services (USCIS) using private courier service. If USCIS receives your application more than 60 days after your I-20 has been issued OR after your OPT has expired, it WILL be DENIED. Mailing address: Keep a copy of your mail receipt and money order receipt, if you get one.
